1. I warrant that I am over the age of 18, in good health, and have no physical or mental conditions that would prevent me or render it inadvisable for me to participate in Sacred Return Yoga & Ayurveda 200 Hour Teacher Training.
2. I have read the Yoga Teacher Training Policies & Agreement (available at www.qiandprana.com/yttfiles) and by signing this contract agree to all policies laid out in the Agreement.
3. I have discussed any physical limitations or conditions that may arise during the Teacher Training with the Lead Trainer, Haunani Drake, and feel comfortable that I may participate fully in the Teacher Training.
4. I agree to arrive on time and attend all intensive weekend classes and mid-week classes to fulfill and successfully complete The Training and receive a certificate of completion.
5. I understand that only 4 mid-week (Tuesday or Thursday) classes may be missed without needing to arrange "Make-Up" hours with The Lead Trainer. I understand make-up hours with the Lead Trainer, Haunani Drake, beyond the days and times listed in the Yoga Teacher Training Policies and Agreement, may be arranged at the discounted rate of \$50/hour or agreed upon by me, The Student, and The Lead Trainer.
6. I agree to inform The Lead Trainer, Haunani Drake, to any issues that may arise including scheduling, health, injury, or other foreseen or unforeseen situations, which may affect my full participation in the Training.
7. I agree to pay a Deposit of \$325, deducted from Tuition, no later than 29 Aug 2019. **Without a deposit, your spot in the teacher training is not guaranteed.**
8. I agree to pay a Tuition of \$2600 before receiving my certificate of completion.
9. I choose the following payment option to pay for my teacher training tuition (initial one):
 - a. _____ IN-FULL, \$2,275, by 7 September 2019, prior to the first intensive weekend.
 - b. _____ 5 MONTH PAYMENT PLAN, \$455/month, due by the 10th of each month from September 2019 - January 2020.

10. I agree to and understand that no part of the Yoga Teacher Training manual (YTT Manual) or handouts may be redistributed, copied, or sold by me or my affiliates, employees, contracted workers, or associations without the written consent of Qi & Prana and Haunani Drake.

I grant permission to The Lead Trainer and other associates of Qi & Prana, to use photographs, videos, comments, or testimonials taken during The Training in future publications, news releases, online and in other communications related to the mission of Qi & Prana. These photographs may be used in promotional, media, video, or as The Lead Trainer sees fit, with or without identification of The Student.

With the knowledge that any of these practices can result in injury, I hereby expressly assume all risks associated with participation in this program, including the risk of injury or damage, and will listen and respect my body to avoid injury or damage.
15. I consent to and permit emergency treatment, medical or otherwise, in the event of injury or illness.

I release all persons associated with Sacred Return Yoga & Ayurveda 200 Hour Teacher Training, Qi & Prana, and Jennifer Haunani Drake, The Lead Trainer, in any manner from any claim whatsoever or account of treatment or service rendered to me during this program. I further agree to indemnify, defend, and hold Qi & Prana and Jennifer Haunani Drake and agents from any claims by or against me arising out of my participation in this teacher training, including all of their attorney's fees and costs.
